**Resolution #23 of 2021**

Premium Pay for Workers Under the American Rescue Plan Act

**WHEREAS**, on March 11, 2021 the American Rescue Plan Act was signed into law to establish the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Funds (SLFRF); and

**WHEREAS**, the SLFRF program is intended to provide support to local governments in responding to the economic and public health impacts of COVID-19 and their efforts to contain impacts on their communities, residents, and businesses; and

**WHEREAS**, the SLFRF program funding can be used to provide premium pay to eligible workers performing essential work in recognition of the increase risk they face during COVID-19; and

**WHEREAS**, the Town Board of the Town of Olive recognizes the employees below as meeting the SLFRF qualifications of essential and eligible workers to protect the health and well-being of the residents of the Town of Olive; and

**NOW, THEREFORE BE IT RESOLVED**, the Town Board of the Town of Olive authorizes the Supervisor to pay the following premium pay stipend on the November 8, 2021 payroll for the following town workers employed during the time period between March 11, 2020 and March 3, 2021:
