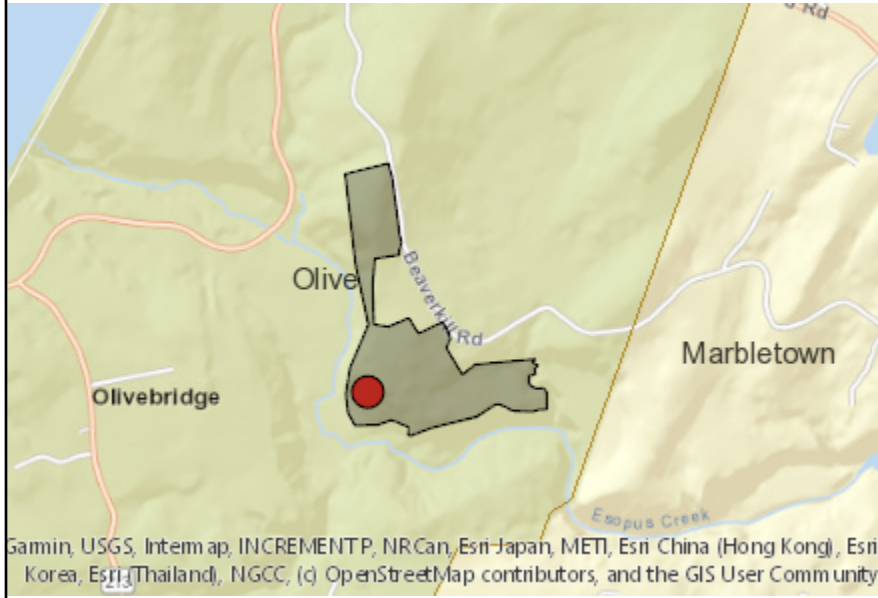

Brief Description of Proposed Action: We are proposing to install 5 pre-fabricated Amish style cabins, each one will be 10'x12' with a 6' porch. These will be placed on a level pad consisting of stone. They will have electricity but not plumbing so no there will be need to connect with our existing septic system. Bathroom facilities will be located in the adjacent "Blue Bath" building. The area around the cabins will be landscaped using low maintenance native plants. Access to the site will be via our existing driveway. A pathway will be created leading from the driveway to the cabins and there will be pathways between the cabins.
