The Town Board audited the monthly bills and reviewed the agenda for the Tuesday night's meeting.

Dianna Carchidi, Assessor gave the Town Board an updated on the tax rolls and some changes to the Senior Exemption. She stated the 2023 Tax Roll has wrapped up successfully. Grievance Day had no attendees and 1 dismissal is anticipated to result in a SCAR hearing. There are changes to RPTL 467: Senior Discount. It encourages towns to max out at \$50,000, or by local option, elect to raise the scale to \$58,400. The Town of Olive is currently at \$32,400. The process for calculating income will also be changed. Dianna stated the Town Board take the change to income into consideration before making any changes.

Board Member Edinger asked if the Town Board was going to revisit the volunteer firefighter tax exemption. Supervisor Sofranko stated he is all for giving a break to volunteer fire fighters; however, the law as is it is now is flawed and not equitable to all equally. The Supervisor expressed support to funding to the next OFD contract to provide annual bonuses for qualified firefighters provided the bonuses are equitable and administered by the OFD.

Request NYS DOT to Reduce the Speed Limit on NYS Route 28 in Boiceville

WHEREAS, the New York City Department of Environmental Protection (DEP) Design and Construction project, identified as CAT- 252, will redesign and relocate the intersection of NYS Routes 28 and 28A in Boiceville, NY creating new traffic lanes and sightlines on both highways in both directions; and,

WHEREAS, The Ashokan Rail Trail termination will be relocated from its present location on the west side of the Esopus Creek over a new RT 28A Esopus Bridge to the east side of the Esopus Creek in Boiceville terminating at the intersection of NYS Route 28 and 28A; and

WHEREAS, the NYS Department of Transportation will be extending a pathway on the east side of NYS Route 28 at the termination of the Ashokan Rail Trail northward on NYS Route 28 to a newly located crosswalk near the Onteora High School; and

WHEREAS, the results of the Safe Routes to School survey conducted in March of 2023 at the Onteora High School located in Boiceville indicated most students would like the opportunity to have safer walking and biking access throughout the hamlet of Boiceville, and

WHEREAS, the Onteora High School and Onteora Middle School, both located on NYS Route 28 in Boiceville, use the Ashokan Rail Trail for athletic activities throughout the school year; and

WHEREAS, The Town of Olive and NYC DEP are acquiring flood buyout properties along this same section of NYS Route 28 in Boiceville to eventually be used for outdoor recreational activities and will have parking areas for such uses creating additional new traffic and traffic patterns on NYS Route 28 between the new Rt 28A intersection and Onteora High School; and

WHEREAS, the existing businesses along this section of NYS Route 28 include a busy supermarket, liquor store, pharmacy, post office, gas station, two restaurants, a bank, and retail stores; and

WHEREAS, a new motel located on Route 28 between Onteora High School and Winne Road has created additional traffic and traffic patterns of drivers who may not be familiar with the area in the immediate vicinity north of the high school; and

WHEREAS, there has been many automobile accidents, including one fatal accident, at the intersection of NYS Route 28 and Old Route 28 where traffic enters and exits from the newly expanded Bread Alone Bakery;

NOW, THEREFORE, BE IT RESOLVED, the Town Board of the Town of Olive requests the New York State Department of Transportation reduce the speed limit to 45mph on NYS Route 28 in Boiceville from the intersection of Lohrer Road to the intersection of Winne Road,

AND FURTHER BE RESOLVED, the Town Board of the Town of Olive requests the New York State Department of Transportation further reduce the speed limit to 35mph on Route 28 in Boiceville from the intersection of Route 28A to the intersection of Piney Point Road.

Updates:

Stucki Embroidery Property- Supervisor Sofranko made an application to AWSMP for a grant to hire a landscape architect to develop the streamside area \$18,000.00. The Supervisor should know in about two weeks if the grant is awarded. If the town receives the grant, they will discuss at the August meeting who they will hire for the project.

Ulster County Park Grant- The town received grant funds to install fencing around the perimeter of Davis Park in the amount of \$17,250 to be matched by the town. The fencing installation should commence on Friday July 14th.

Highway Cold Storage Garage- The engineers have made a site visit and done some soil testing and should be starting the design work soon. They stated that the soil was good so no further testing should be needed.

Committees, Commission, Department Reports:

Parks and Recreation Committee-Scott Kelder, Liaison

Supervisor Sofranko acknowledged Gene Sorbellini for a well-run Day Camp. Gene stated that Day Camp is very popular this year with approximately 100 kids per day in the first 4 days. He commented that the pool is a big hit. They have a new leadership team and they are doing well. Matt Savagty from Cornell Cooperative will be there tomorrow to do a streamside visit and they go to the Library on Thursday. The Town of Olive little league field was selected to host a baseball tournament which is great for the Mountain Valley Little League program. Adult softball is going well. The pool has had mixed weather conditions to contend with, but there was still 93 people in the pool just tonight. On a regular nice sunny day there is approximately 100 people in the pool. Parking has become an issue with people parking along Lang Road. The free concert in the park will be held on August 3rd. The Day Camp and pool facilities were inspected by the County Health Department and result were flawless. Gene commented that there is a need for new picnic tables at Shokan Park and he would request using reserve funds to purchase 10 picnic tables.
